If any damages are assessed in excess of \$500.00 (Five hundred dollars) you will be responsible for additional expenses. Please return a signed copy of this contract, with your **\$500.00 deposit made payable to Corpus Christi Catholic Church** at 3220 NW 7 Ave. Miami, FL 33127 within two weeks of receipt to guarantee your reservation. We cannot guarantee your reservation without the deposit. **The balance is due two weeks prior to the retreat day. Any additional amount due must be paid at the time of receiving the keys. No exceptions!** If any damages are assessed in excess of \$500.00 (Five hundred dollars) refundable after final inspection for any damage done to the house, you will be responsible for the additional expenses. **Cancellations must be made in writing**, no later than sixty (60) days before the date reserved in order to receive 50% of your deposit. Cancellations made in less than the 60 days will render your deposit non-refundable and your group will also be responsible for paying Corpus Christi Catholic Church the additional amount of \$750.00, for a total of \$1,100.00 late cancellation fee. There will be no exceptions.
